- 'Activity' means the activity provided by 1770 and participated in by the Customer sandboarding, fishing, swimming, climbing of lighthouse stairs
- '1770' means 1770 Environmental Tours Pty Ltd ACN 112 999 130, its servants, employees, agents, directors and officers, subcontractors, and principals.

DECLARATION

I, the undersigned, declare that:

- 1.I am 18 years of age or older, or if I am signing on behalf of a child, I warrant that I am that child's parent or guardian and agree to be bound by the terms of this Agreement.
- 2.I have no medical disorders or conditions that would cause danger to myself or others while participating in the Activity or using the Equipment.

- 2.I agree to indemnify, release and hold harmless 1770 from and against any liability arising out of any injury, loss, damage or death caused to my person (my child, or my property or any other person or their property arising from or in connection with my participation in the Activity or use of the Equipment, whether such injury, loss, damage or death was caused directly or indirectly by my (or my child's) negligence, breach of contract or any act or omission whatsoever, or 1770's negligence, breach of contract or any act or omission whatsoever, or any other parties negligence breach of contract or any act or omission whatsoever of 1770 and also other than where the injury, loss, damage or death was caused solely by the negligence of 1770, its servants, employees or agents.
